Location	Typical Rebate	Net Cost
California	\$1,000-\$2,000	\$8,500-\$9,500
Texas	\$2,500	\$8,000

## Why Time Matters in Solar Rebates

Germany's EEG subsidies decreased from EUR0.43/kWh in 2010 to EUR0.073/kWh today. This urgency principle applies universally - solar rebates diminish as markets mature. Install before program revisions!
